1. COVID-19 INFORMATION

Important notes during the challenging times of COVID-19 Pandemic.

A number of documents have been developed by CEV and FIVB to protect the health, safety and well-being of athletes, coaches, officials, staff and all persons involved in the organisation of the event:

- The CEV Competitions Hygiene Guidelines,.
- CEV Hyaiene Guidelines Beach Volleyball Specifications
- The 2022 FIVB COVID-19 Protocol

Following a recommendation of the CEV Medical Commission, in countries where there are no restrictions in place to curb the spread of the novel coronavirus, the organisers and all relevant stakeholders do not have to follow the provisions of the relevant, latest CEV Hygiene Guidelines – Beach Volleyball Specifications.'

Nevertheless and to ensure a safe event for all persons involved, the following recommendations and guidelines to every accredited participant of the event are in place:

- Hygiene measures should be always observed. These include frequent and thorough hand washing and coughing and sneezing into the crook of the arm or into a paper handkerchief.
- When a minimum distance of 1.50m cannot be maintained in closed areas, medical mouth protection is recommended. The same principle is also recommended for local and international transportation
- Persons with a confirmed SARS Cov-2 infection will not be allowed access to the venue and will be required to go into isolation.

Travel Restrictions (constantly updated)

Hungary has lifted its COVID-19 entry regulations on 7th of March, 2022.

The access to the location of Preliminary Inquiry will be controlled to avoid mass gathering.

Players and Delegation members are required to attend the Preliminary Inquiry and present their passports, accessories to the Technical Delegate. Failure to provide these documents will entail a disqualification of the team concerned.

All players wishing to take part to a VW Beach Pro Tour Futures Event must fully comply with the requirements set by the CEV/FIVB regulatory framework.

These includes, but not limited to:

- Completed and signed the 2022 Beach Volleyball Player Participation Agreement and BVB-10 Annual Health Certificate document duly uploaded to the VIS
- have completed the FIVB anti-doping Education and Certification program
- have undertaken the FIVB E-learning Course on the Prevention of Competition Manipulation course

The awarding of the FIVB World Ranking points will be applied for this event as per the FIVB Beach Volleyball Sport Operations Manual, in case a fair access to all eligible and registered to participate athletes is ensured and will be confirmed after the issuing of the confirmed lists.

Uniform and Accessories:

The playing tops/tanks will be provided by the organiser for all Main Draw and Qualification players. Shorts/bottoms and accessories must be provided by the players and/or by their sponsors.

If required by the Technical Delegate, other uniforms and accessories will be checked during the Preliminary Inquiry. Athletes of the same team must wear the same colour and style of shorts.

The display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.
