RULES OF THE GAME	<p>According to the FIVB Official Beach Volleyball rules in their latest edition.</p> <p>Exceptions – Coaching: CEV will apply the new FIVB Coaching Guidelines for Beach Volleyball, circulated by FIVB on 08.07.2025.</p> <p>To request an accreditation for a Coach the Accreditation of a Coach (BV-05) form, available on the following link: https://inside.cev.eu/documents/beach-volleyball-documents, scroll down until section “Beach Volleyball Forms/National Federations” shall be duly completed and uploaded to the CEV Cloud in the respective folder created for the participating NF at least by 06.08.2025 (-14 days) by using the following link: https://cloud.cev.eu/url/U20BVECHs_Accreditation2025</p> <p>The BV-05 form should be uploaded to the CEV Cloud in the respective folder created for the participating NF by using the following link: https://www.cev.eu/beach/agegroups/2025/u20/</p>		
REGISTRATION DEADLINE	<p><u>Players registration by 01.08.2025</u></p> <p>In case of two or more registered teams National Federations need to specify the team order (1, 2, etc.) by email to beach@cev.eu.</p>		
ADMISSION AND SEEDING	According to 2025 CEV U20 Country Ranking and the provisions mentioned in the CEV Beach Volleyball Competition Regulations and CEV Beach Volleyball Guidelines.		
RIGHT OF PERTICIPATION & REGISTRATION	<p>An athlete wishing to take part in a CEV sanctioned competition must possess the nationality of the country he/she intends to represent and must fully comply with the requirements laid down by the FIVB Sports Regulations. In addition, each athlete needs to have the following documentation completed/updated on his/her VIS profile:</p> <ul style="list-style-type: none">• upload the BV-01 Athlete’s Commitment and BVB/10 Annual Health Certificate forms to his/her VIS profile• have completed both the FIVB Play Clean as well as the Prevention of Competition Manipulation online courses that can be found here <p>Athletes’ wishing to participate shall be aged under 20 years on 31st of December of the year during which the respective Championships is held (for this season born on 1st of January, 2006 or after).</p>		
UNIFORMS	<p><u>The Organiser will not provide uniforms to the participating teams.</u></p> <p>As a result the participating National Federations shall provide their players with minimum 2 sets of uniforms in different colours according to the layout specified in Official Communication document and may exploit them commercially (excluding the following product categories: alcohol (spirits), tobacco & pornography).</p> <p>Participating National Federations are responsible to bring their own shorts/bikini bottoms as per the provisions of the CEV Beach Volleyball Regulations and the Official Communication. Players may use gear and accessories as defined in the CEV Beach Volleyball Guidelines.</p> <p>To their coaches entering the Field of Play, as per the FIVB Coaching Guidelines for Beach Volleyball document, available on the event’s page of the CEV website.</p>

<p>TRAINING</p>	<p>Training courts will be available on site from 19.08.2025, with one court per gender.</p> <p>Please note that reservation of training can be made one day in advance for the next day only and each team is entitled to make one reservation per day for 30 minutes. Additional training session may be available only if the courts will be available.</p> <p>To reserve a court please address to: asistencia@fmvoley.com</p>
<p>CONTRIBUTION FEE</p>	<p>As per the Official Communication document, a contribution fee is a fee paid for each Main Draw or Qualification team member to the organiser in order to contribute to its accommodation and local transportation.</p> <p>The National Federation shall bear all costs related to all accredited team members. For the CEV Age Group Beach Volleyball European Championships this amount equals EUR 100 (one hundred Euros) per delegation member per night for two players and one team official (coach, head of delegation, doctor, and physiotherapist). The respective National Federation participating in the Main Draw shall pay the contribution fee for five days in total, even if the duration of the stay of its delegation members is shorter (Main Draw 5 x 100, - EUR = 500, - EUR). The same daily contribution fee shall be paid for two (2) days for any teams participating in the Second-round Qualifier, if such occurs (Qualification 2 x 100 = 200, - EUR). For teams qualifying to the Main Draw through the Second-round Qualifier, the respective National Federation shall pay an additional contribution of 100, - EUR per delegation member per day for additional four (4) days, six (6) days in total even if the duration of the stay of its delegation members is shorter (Qualification + Main Draw 200 + 400 = 600, - EUR).</p> <p>For additional team member(s) the rate is communicated in the Board & Lodging section.</p>

ACCREDITATION	<p>Organisers will provide all organising committee members, CEV officials, referees, players, team official (accredited coach, head of delegation, doctor, physiotherapist), technical staff with official accreditation cards and will ensure that only those people will have access to the designated venue areas.</p> <p>An individual is considered a team official when his/her accreditation request is duly submitted, fulfill all the requirements and hold an accreditation for a competition.
