CONTRIBUTION FFF

As per the Official Communication document, a contribution fee is a fee paid for each Main Draw or Second-round Qualifier team member to the organiser in order to contribute to its accommodation and local transportation.

The National Federation shall bear all costs related to all accredited team members. For the CEV Age Group Beach Volleyball European Championships this amount equals EUR 100 (one hundred Euros) per delegation member per night for two players and one team official (coach, head of delegation, doctor, and physiotherapist). The respective National Federation participating in the Main Draw shall pay the contribution fee for five days in total, even if the duration of the stay of its delegation members is shorter (Main Draw 5×100 , – EUR = 500, – EUR). The same daily contribution

	fee shall be paid for two (2) days for any teams participating in the Second-round Qualifier if such occurs (Second-round Qualifier 2 x 100 = 200, - EUR). For teams qualifying to the Main Draw via the Second-round Qualifier, the respective National Federation shall pay an additional contribution of 100, - EUR per delegation member per day for additional four (4) days, six (6) days in total even if the duration of the stay of its delegation members is shorter (Second-round Qualifier + Main Draw 200 + 400 = 600, - EUR). For additional team member(s) the rate is communicated in the Board & Lodging section.

	If the organiser will not receive the fees in time, the CEV Supervisor has the right to exclude the concerned teams from the event.
	Each participating National Federation has to present a copy of the confirmed money transfer to the CEV Supervisor at the respective Preliminary Inquiry.
	Every person is responsible for any and all extra expenses at the hotel such as mini-bar, phone calls, laundry, etc. These expenses must be paid at checkout time.



	An individual is considered a team official when his/her accreditation request is duly submitted, fulfill all the requirements and hold an accreditation for a competition. National Federation may request a maximum number of 2 (two) accreditation for team officials per team, however the respective organiser may agree on a higher number.

No NEED of a person dedicated to the reservation


Teams can reserve automatically their training slot

The Technical Delegate and the Competition Director Will set specific rules for each Competition

To register a player needs to insert:

- Team's Name
- Country
- Gender
- Telephone number (for quick communication)
- Email
- FIVB NUMBER
- And verify his mail




Step 2: Login


- The Player sees all the events available, but
- He will see only the courts available where his FIVB number is validated and authorized for Court reservations (ex. ECH U18 Beach Volleyball)

Step 3: Choose the event and make the reservation

- The Player choose the time slot he requires
- Courts can be at exclusive use or shared
- Time slots can be 45', 60' or different times depending on Competition rules

When a court is SHARED, after the first reservation another team can join the same court and time


When no other Team joined the training

When 2 teams join the time slot no more Teams can be added to the reservation



Feature: Edit profile

The Player can enter in his profile page to edit Team Name (in case of change of the team mate) or change email or Password.

Being the FIVB Number fixed for each Player, it cannot be changed.



Basic Rules for Training Reservations on CEV Competitions

- 1 The number of the courts available for Training, the days and the times depend on the main competition schedule
- 2 In order to make more training spots available, the duration of the sport can be changed from one hour to 45
- 3 Teams cannot have training spots at their exclusive use. If another team makes the request they should share the court for training
- 4 The courts can be reserved only for the day after (no long time earlier reservation)
- 5 Teams can enjoy additional spots for training in case no other team requests it
- 6 Reservation can be made at least 15 minutes before the start of the training
- 7 Cancellations need to be done with reasonable advance in order to allow other teams to join the free court
