Mandatory attendance is required for both players of each team at the Preliminary Inquiry.

Access to the location of the Preliminary Inquiry will be controlled to avoid mass gatherings.

All players must attend the Preliminary Inquiry and present the following to the Technical Delegate:

- their passport,
- Accessories

Failure to provide these documents will entail a disqualification of the team concerned.

To compete in a Volleyball World Beach Pro Tour Futures Europe event, players must fully comply with the CEV/FIVB regulatory framework, including but not limited to the following requirements:

### *World Ranking Points*

---

The awarding of FIVB World Ranking points for this event will follow the provisions of the FIVB Beach Volleyball Sport Operations Manual.

Ranking points will be granted only if fair access to participation is ensured for all eligible and registered athletes.

The final confirmation of the ranking points' allocation will be made after the official Confirmed Entry Lists are issued.

## *Uniform and Accessories*

---

The organiser will provide playing tops/tanks for all Main Draw and Qualification players. The layout of tops/tanks are specified in the CEV Venue Branding Guidelines, and the number of tops/tanks is defined in the Event Rider already shared by CEV to each organiser.

Players are responsible for providing their own shorts/bottoms and accessories, either personally or through their sponsors.

If requested by the Technical Delegate, additional uniforms and accessories may be inspected during the Preliminary Inquiry.

Athletes from the same team must wear shorts of the same color and style.

The design of uniforms (tops/tanks, shorts etc.) and the layout of accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.

***CEV will transfer the prize money in Euros (EUR) to the bank account of the respective teams' National Federations. The amount will be converted from USD to EUR using the exchange rate published on the first working day after the final match of the event ([ecb.europa.eu](http://ecb.europa.eu)).***

***As per the instructions provided by CEV after the tournament, each team's National Federation is required to send an invoice to CEV for the correct amount in Euros. CEV will transfer the funds only upon receipt of the invoice.***

***Each athlete is required to contact their respective National Federation directly in order to receive their share of the prize money.***

**Note:**

Athletes are responsible for paying any applicable taxes on their earnings in their respective countries.
