The access to the location of Preliminary Inquiry will be controlled to avoid mass gathering.

All players must attend the Preliminary Inquiry and present to the Technical Delegate:

Failure to provide these documents will entail a disqualification of the team concerned.

Rules of the Game:

Following the update from the FIVB Rules of the Game and Refereeing Commission over the enforcement of an appropriate game pace, circulated by the FIVB on April 25th, the following important points of reinstating **the 12-second rule between rallies,** will be applied:

- Immediate Side Change: Players must cross directly under the net from their position on the court
 without delay. Exceptions apply only in specific cases where switching around the poles is quicker
 or if a force majeure event or previously certified injury, prevents direct crossing.
- 2. **Use of Towels for Sunglasses Cleaning:** Players may access the towel hanging on the rope connected to the pole on each side of the court only if necessary and without causing delays. However, towels will not be assigned to specific teams on either side.

Coaching at the field of play (test period):

Following a decision from the FIVB Board of Administration, a test phase allowing coaching at the field of play will be conducted during this event, Coaching guidelines to support the implementation of the test have been developed and are attached to the Event's Regulations document.

World Ranking Points

The awarding of the FIVB World Ranking points will be applied for this event as per the FIVB Beach Volleyball Sport Operations Manual, in case a fair access to all eligible and registered to participate athletes is ensured and will be confirmed after the issuing of the confirmed lists.

Uniform and Accessories:

The organiser will provide playing tops/tanks for all Main Draw and Qualification players, in accordance with the breakdown shared by the CEV.

Players must provide their own shorts/bottoms and accessories, either personally or through their sponsors.

If requested by the Technical Delegate, additional uniforms and accessories will be inspected during the Preliminary Inquiry.

Athletes from the same team must wear uniform of same colour.

The uniforms guidelines including the display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.

Prize money will be paid in cash to the athletes on-site by the organiser. All athletes must present their Identity Card/Passport for collection at a designated day and time, to be announced during the Main Draw Preliminary Inquiry.

Note:

Athletes are responsible for paying any applicable taxes on their earnings in their respective countries.

3. GENERAL MATTERS

Official Airport

The official airport confirmed by the organiser is as follows:

Name of the airport: Budapest Airport / Liszt Ferenc International Airport Distance from the airport to venue: 28 km

Recommended means of transport:

- Taxi: taxi services have an official fee, all service providers must use the same fee. International providers (eg. Uber and Bolt) are also available through their application.
- Public transportation: the bus 100E will take you for only 2.200 HUF (5-6 EUR) from the airport to the city center (Deák Ferenc tér). From Deák Ferenc tér, you can take the subway line M2 to Batthyány tér from where you can take the suburban railway H5 and get to Timár utca station, which is 200m walking distance from the venue.

Board and Lodging

The organisers will NOT provide hotel accommodation for athletes or accompanying persons.
