RULES OF THE GAME	According to the FIVB Official Beach Volleyball rules in their latest edition. Exceptions – Coaching: Following the respective FIVB guidelines, the presence of a coach inside the field of play is allowed in all CEV Age Group Beach Volleyball European Championships, provided they are accredited through the respective BV-05 form. (please scroll down until section "Beach Volleyball Forms/National Federations") and associated to the team in the VIS. REGISTRATION DEADLINE	All registration should be made through the CEV/FIVB VIS online registration platform. Player's registration by 11 August 2026 In case of two or more registered teams National Federations need to specify the team order (1, 2, etc.) by email to beach@cev.eu 11 August 2026		
ADMISSION AND SEEDING	Allocation of Teams to the Confirmed List according to 2026 CEV U22 Country Ranking and the provisions mentioned in the CEV Beach Volleyball Competition Regulations and CEV Beach Volleyball Guidelines. As per the Official Communication document, seeding of the teams within the Main Draw, Qualification Tournament and Reserve List will be based on the sum of the athletes' CEV Entry Ranking points on the day of the Technical Meeting and as defined in the CEV Beach Volleyball Competitions Regulations. To support the event promotion, the team of the Hosting National Federation with the highest CEV Entry ranking points will be seeded in Seed 1 in both genders.		
RIGHT OF PARTICIPATION & REGISTRATION	An athlete wishing to take part in a CEV sanctioned competition must possess the nationality of the country he/she intends to represent and must fully comply with the requirements laid down by the FIVB Sports Regulations. In addition, each athlete needs to have the following documentation completed/updated on his/her VIS profile: • Upload the BV-01 Athlete's Commitment and BVB/10 Annual Health Certificate forms to his/her VIS profile • Have completed both the FIVB Play Clean as well as the Prevention of Competition Manipulation and the Safeguarding courses that can be found here Athletes' wishing to participate shall be aged under 22 years on 31 st of December of the year during which the respective Championships is held (for this season born on 1st of January, 2005 or after).		
UNIFORMS	The Organiser will not provide uniforms to the participating teams . As a result the participating National Federations shall provide their players with minimum 2 sets of uniforms in different colours according to the layout specified in Official Communication document and may exploit them commercially (excluding the following product categories: alcohol (spirits), tobacco & pornography). Participating National Federations are responsible to bring their own shorts/bikini bottoms as per the provisions of CEV Beach Volleyball Competition Regulations and

CONTRIBUTION FEE	As per the Official Communication document, a contribution fee is a fee paid for each Main Draw and Qualification teams in order to contribute to its accommodation and local transportation. The National Federation shall bear all costs related to all accredited team members. For the CEV Age Group Beach Volleyball European Championships this amount equals EUR 130 (one hundred and thirty Euros) per delegation member per night for two players and one team official (coach, head of delegation, doctor, and physiotherapist). The respective National Federation participating in the Main Draw shall pay the contribution fee from the official day of arrival until the day after of their elimination from the competition. The same daily contribution fee shall be paid for two (2) days for any team participating in the Qualification Tournament if such occurs (Qualification 2 x 130 = 260, - EUR). For teams qualifying to the Main Draw via the Qualification Tournament, the respective National Federation shall pay an additional contribution of 130, - EUR per delegation member per night until the day after their elimination from the competition.
