<b>RULES OF THE GAME</b>	<p>According to the FIVB Official Beach Volleyball rules in their latest edition.</p> <p><u>Exceptions – Coaching:</u> Following the respective FIVB guidelines, the presence of a coach inside the field of play is allowed in all CEV Beach Volley Nations Cup 2026 Preliminary Phase events, provided that these are duly accredited through the respective <a href="#">CEV BV-05 form</a>.</p> <p>The National Federation is responsible for creating the coach profile in the VIS and registering the coaches according to the Coaches Regulations. Coaches not properly registered in the VIS system will not get accreditation to the event and will not be authorized in the field of play.</p> <p>A detailed document describing the obligation and rights of coaches entering the Field of Play is available on the CEV website. <a href="https://www.cev.eu/beach/nations-cup/2026">https://www.cev.eu/beach/nations-cup/2026</a></p> <p>The BV-05 form should be uploaded to the CEV Cloud in the respective folder created for the participating NF by using the following link: <a href="https://cloud.cev.eu/url/NCPP2026TURAccreditation">https://cloud.cev.eu/url/NCPP2026TURAccreditation</a></p> <p>Following the update from the FIVB Rules of the Game and Refereeing Commission over the enforcement of an appropriate game pace, circulated by the FIVB on April 25<sup>th</sup>, the following important points of reinstating the <b>12-second rule between rallies</b>, will be applied:</p> <p>1. <b>Immediate Side Change:</b> Players must cross directly under the net from their position on the court without delay. Exceptions apply only in specific cases where switching around the</p>

Use of Towels for Sunglasses Cleaning:</b> Players may access the towel hanging on the rope connected to the pole on each side of the court only if necessary and without causing delays. However, towels will not be assigned to specific teams on either side.</p>

<b>COMPETITION PARAMETERS &amp; RIGHT OF PARTICIPATION</b>	<p>Competition parameters are detailed in the CEV Beach Volley Nations Cup Official Communications documents.</p> <p>An athlete wishing to take part in a CEV competition must possess the nationality of the country they intend to represent and must fully comply with the requirements laid down by the FIVB Sports Regulations and in the CEV Regulatory Framework. In addition to that, each athlete needs to have the following documentation completed/updated on their VIS profile:</p> <ul style="list-style-type: none"> <li>• Upload the CEV Athlete's Commitment, the FIVB Health Certificate form to their respective profile in the VIS profile</li> <li>• Have completed both the FIVB Play Clean as well as the Prevention of Competition Manipulation courses, that can be found <a href="#">here</a></li> </ul>
<b>UNIFORMS</b>	<p><b><u>The Organiser will not provide uniforms to the participating teams</u></b></p> <p>Each participating National Federations shall provide their players with minimum 2 sets of uniforms (tops) in different colors and may exploit them commercially as per the provisions of the CEV Beach Volleyball Regulations and in the Official Communications documents.</p> <p>The uniforms numbering should be from 1 to 4, so that each player could be easily identified throughout the whole competition.</p> <p>Players may use gear and accessories as defined in the CEV Beach Volleyball Guidelines.</p> <p>Coaches entering the Field of Play need to abide the provisions of the uniform according to the CEV Coaching Regulations document.</p> <p>In case of non-conformity to the layouts and/or not using the uniforms during the matches, official warm-up and awarding ceremony, sanctions will be applied according to CEV Beach Volleyball Regulations.</p>

<p><b>CONTRIBUTION FEE</b></p>	<p>As per the CEV BV Nations Cup Official Communication document, a contribution fee is a fee paid by each participating National Federation to the organiser to contribute to their accommodation and local transportation.</p> <p>Such fee is 130, - EUR (one hundred Euros) per delegation member, maximum of 6 persons, including four (4) athletes and up to two (2) duly accredited team delegation members (coach, head of delegation, doctor, and physiotherapist) per night.</p> <p>The organiser will provide the four (4) athletes and up to two (2) duly accredited team delegation members with hotel accommodation in twin rooms and full board from the day of the Preliminary Inquiry with dinner until the morning after the end of the competition with breakfast.</p> <p>The respective National Federation shall pay the contribution fee from the official day of arrival until the official day of departure if the duration of the stay of its delegation members is shorter.</p> <p>The respective National Federation shall pay the fee 7 days before the start of the event.</p>
