All formalities detailed in the CEV Official Communication No2 needs to be submitted for the athletes participating in the Preliminary Phase latest 7 days prior to the respective pool.
PRELIMINARY INQUIRY & TECHNICAL MEETING	Preliminary Inquiry: <u>Friday 2nd of October from 19:00 to 20:00 at the competition venue.</u> Each Club has to be present with the full Delegation at Preliminary Inquiry. Players and Delegation members are required to present their passports, uniforms and accessories. Only people accredited through the respective CEV forms will be acknowledged as delegation members. A technical meeting will be organised after the Preliminary Inquiry and needs to be attended by the Head of Delegation of each Club, to detail all competition parameters.
UNIFORMS	<u>The Organiser will not provide uniforms to the participating Clubs</u> Participating Clubs shall provide their players with uniforms (tank top and shorts) in different colors according to the layout specified in the competition Official Communications n.1 document and may exploit them commercially excluding the following product categories: alcohol (spirits), tobacco & pornography. <u>The uniforms of each Club need to be numbered from 1 to 6, and each athlete will bear the same uniform number throughout the competition.</u> <u>For the production of athletes uniforms the Event and the CEV logo are available in the CEV Cloud https://cloud.cev.eu/url/BVEC_uniformLogos</u> Athletes may use gear and accessories as defined in the CEV Beach Volleyball Guidelines. Coaches entering the Field of Play, need to abide to in regard to uniform the provisions of the CEV Coaching Regulations document, available in the Beach Volley European Cup section of the CEV website.
SEEDING	Clubs will be seeded in the competition as per the CEV Beach Volleyball European Cup Drawing of Lots

RULES OF THE GAME	According to the FIVB Official Beach Volleyball rules in their latest edition. Exceptions: - Coaching: The presence of a coach inside the field of play is allowed provided that the person is accredited through the respective CEV BV-05 form. - Substitution: Each club is entitled to 1 substitution per match (an athlete may leave the game and re-enter only once, and only to same athlete), in line with the provisions of the Official Communications document N.2.
TRANSPORT	Participating Clubs are responsible for their own international and domestic transportation and for any further expenses such as visa or airport taxes.
OFFICIAL DAYS ARRIVAL AND DEPARTURE	<u>Arrival for all Clubs:</u> Friday 2nd of October <u>Departure for all Clubs:</u> following end of competition (Monday, 5th of October)
BOARD AND LODGING	As per the competition Official Communications, each Club is responsible to cover their accommodation costs. The recommended solutions are: Accommodation: http://www.canadahotelbudapest.hu/ Local airport transfer: https://bkk.hu/en/travel-information/airport-express/ Please note that no shuttle will be provided between your accommodation and the competition venue – We recommend public transport. It takes 30 mins. Or bike sharing: https://molbubi.hu/en/ (less than 5 km) You may also use taxi applications (Uber, Bolt).
VISA	Delegation members are requested to apply early enough for their visas, whenever needed. The Hosting National Federation should be contacted to receive an invitation letter for the event if needed.
ACCREDITATION	All accreditation requests need to be uploaded in the CEV Cloud through the respective BV-05 or BV-06 forms (form to be uploaded in the respective folder created for your club that you have received via email from beachclubs@cev.eu). An individual is considered a delegation member when their accreditation request is duly submitted, fulfill all the requirements and confirmed by the CEV Supervisor on site.
