

	A technical meeting will be organised after the Preliminary Inquiry and needs to be attended by the Head of Delegation of each Club, to detail all competition parameters.				
UNIFORMS	The Organiser will not provide uniforms to the participating Clubs  Participating Clubs shall provide their players with uniforms (tank top and shorts) in different colors according to the layout specified in the competition Official Communications n.1 document and may exploit them commercially excluding the following product categories: alcohol (spirits), tobacco & pornography.				
	The uniforms of each Club need to be numbered from 1 to 6 and each athlete will bear the same uniform number throughout the competition.




BOARD AND LODGING	As per the event Official Communication, each Club is responsible to cover their accommodation costs.
