	The National Federation shall bear all costs related to all accredited team members. For the CEV Age Group Beach Volleyball European Championships this amount equals EUR 100 (one hundred Euros) per delegation member per night for two players and one team official (coach, head of delegation, doctor, and physiotherapist). The respective National Federation participating in the Main Draw shall pay the contribution fee for five days in total, even if the duration of the stay of its delegation members is shorter (Main Draw 5 x 100, - EUR = 500, - EUR). For additional team member(s) the rate is communicated in the Board & Lodging section.
